§ 1 LEGAL BASIS FOR THE PROCESSING OF PERSONAL DATA

(1) if we get a person's consent for processing of personal data, article 6 serves par. 1 lit. a EU data protection Regulation (GDPR) as the legal basis.

(2) for the processing of personal data, which is necessary for the performance of a contract, whose party is the person, article 6 serves par. 1 lit. b GDPR as the legal basis. This also applies for processing operations that are necessary for the implementation of pre-contractual measures.

(3) if processing of personal data for the performance of a legal obligation is required, our company's person to the article 6 par. 1 lit. (c) GDPR is used as the legal basis.

(4) in the event that vital interests of the personal data or another natural person require a processing of personal data, article 6 paragraph 1 lit. d GDPR is used as the legal basis.

(5) processing to maintain a legitimate interest of our company or a third party is required and outweigh the interests, rights and freedoms of the person concerned the former interest does not, so article 6 para 1 is lit. f GDPR as is used the legal basis for the processing.

§ 2 DATA DELETION AND STORAGE DURATION

(1) the personal data of the person shall be deleted or blocked, if the purpose is storage is cancelled.

(2) Data can be stored in addition, if this has been provided by the European or national legislator in Union legal regulations, laws or other regulations, the person in charge.

(3) Blocking or deletion of data applies still if a storage deadline prescribed by the above mentioned standards, except that there is a necessity for further storage of data for a conclusion of the contract or the performance of a contract.

§ 3 INFORMATION ABOUT THE COLLECTION OF PERSONAL DATA

(1) the following information on the collection of personal data when using our website. Personal data are all data, which are personally available to you, such as name, address, e-mail addresses and user behavior.

(2) in the case of your contacting us by E-Mail or through a contact form the data communicated by you (your email address, if applicable) Your name and your telephone number) stored by us to answer your questions. The data collected in this context we delete after the storage is no longer necessary, or restrict the processing if there are statutory retention obligations.

(3) if we want to draw for individual features of our offer on contracted service provider or use your data for advertising purposes, we will inform you in detail about the respective operations below.

Here, we call also the criteria set by the storage duration.

Collection of personal data

When the merely informational use of our web site, so if you choose not to register or contact us, we collect only the personal data that your browser transfers to our server. If you want to look at our web site, we collect the following data that are technically necessary for us to show you our website and to ensure the stability and security (legal basis for this is article 6 para of 1 S. 1 lit. f GDPR):

- IP address
- Host name
- Date and time of the request
- Time zone difference to the Greenwich mean time (GMT)
- Contents of the request (specific page)
- Access status/HTTP status code
- Each amount of data
- Website of the request arrives (referrer)
- The specific pages of our site you have visited
- Browser: Type, version, and language
- Operating system: Type and version
- With JavaScript enabled in addition:
 - Screen resolution
 - Color depth
 - Size of the browser window
 - Installed browser plug ins

§ 4 OTHER FUNCTIONS AND USE OF OUR WEBSITE

(1) in addition to the purely informative use of our website, we offer various services that you can use if you are interested. To do this, you must specify generally more personal data that we use for the provision of the relevant service and apply the above principles to the data processing.

(2) in the case of your contacting with the service provider by email or via the contact form, your email address are and if this your name, your phone number and [...] specify stored by us to answer your questions.

(3) partly we use for processing your data to external service providers. These have been carefully selected by us and commissioned, are tied to our instructions and are regularly inspected.

(4) as far as our service providers or partners are located in a country outside of the European Economic Areas (EEA), we inform you about the consequences of that fact in the description of the offer.

SECTION 5 RIGHTS OF THE PERSON CONCERNED

Below we enlighten you 15 GDPR on your affected rights as per article. These rights may at any time take and therefore directly contact us. If you request us to these rights, we will examine thoroughly, taking into account the related legal requirements and obligations. We will ask for more information from you if necessary. We will explain in detail the results of our audit and our approach to meet your request. It's possible that we cannot fully meet your needs in the way you want.

This should deter you not, against us to claim your rights, or to check with us in this regard. Gladly we will answer all your inquiries.

(1) the right to information

You have the right at any time to request information, whether and what data to the processed your person we are. This includes also information for the purposes of the processing, to recipients whom we have disclosed information about you if necessary, the planned storage period and the origin of such data if applicable, if we should have risen this directly with you. In addition, you have the right to a single free copy of your personal data stored by us. For the creation of the following copies we reserve the right, to charge a management fee.

(2) the right to rectification

You have the right to require the correction of inaccurate data we have stored about your person, to us. This includes the right to complete incomplete personal data.

(3) the right to cancellation

You have the right to request the deletion of data we have stored about your person, we. If we should have published information from you, including also our commitment within the framework of the "right to be forgotten " are in accordance with article 17 para. 2 falls GDPR taking into account available technology and the cost of implementation your deletion request all Links to these data as well as copies or replication of data relating to other published personal data for the processing of this responsible to forward.

(4) the right to limitation of processing

You have the right to require the restriction of the processing of data that we have stored on your person, to us. After processing this data is possible only with your consent or to just a few, statutory purposes.

(5) the right to object to the processing of

As far as the processing of your personal data, we rely on the interests , you may appeal against the processing. This is the case, if the processing in particular, not to the performance of a contract with you is required, which is depicted in the following description of the functions each of us. Upon exercise of such conflict, we ask for explanation of the reasons why we should process your personal data not as we performed. In case your justified opposition, we will examine the situation and are either set the data processing or customize or show you our compelling legitimate grounds upon which we continue processing.

Of course you can object to the processing of your personal data for purposes of advertising and data analysis at any time. Your opposition on advertising can tell us about the listed above contact way.

(6) the right to revoke a privacy consent

If you have given consent to the processing of your data, you can cancel it at any time. Such cancelation affects the admissibility of the processing of your personal data, after you have pronounced him against us.

(7) the right to data portability

You have the right to receive data about yourself , that you have provided to us, in a structured, conventional and machine-readable format for the purpose of transferring to a different manager. This includes the direct transfer of us to the other responsible at your request now and taking account of the existing technical possibilities.

(8) the right of appeal to a supervisor

You have the right to complain at any time when a data protection authority about our processing of your personal data.

(9) automated decision making including profiling

You have the right to information on the existence of an automated decision making including profiling in structures with article 22 involved logic, as well as the scope, and that paragraphs of 1 and 4 GDPR and meaningful--at least in these cases, information about the to get desired effects of such processing for the person concerned.
